

TERMS AND CONDITIONS FOR EASTERN CREEK QUARTER

“ECQ Outlet Grand Opening – Free Tote Bag Giveaway”

PROMOTION

1. Information on how to enter and gifts form part of these Terms and Conditions. Participation in this “ECQ Outlet Grand Opening – Free Tote Bag Giveaway” Promotion (“Promotion”) is deemed acceptance of these Terms and Conditions.

ELIGIBILITY

2. Subject to condition 3, this Promotion is only open to Australian residents aged 18 years and over.
3. The following are ineligible: (i) employees of the Promoter or any of the tenants or retailers or their staff at Eastern Creek Quarter or any of the Promoter’s agencies that are associated with the Promotion; (ii) the spouse, de facto spouse, parent, child or sibling (whether natural or by adoption) of an excluded employee; and (iii) any person who the Promoter has previously notified is not permitted to enter the Promoter’s promotions.

PROMOTION PERIOD

4. This Promotion commences at 10:00 am Australian Eastern Daylight Time (“AEDT”) 25 March 2026 and ends at 6:00pm AEDT on 28 March 2026 or when all 2,400 valid claims have been received, whichever occurs first (“Promotion Period”).

HOW TO CLAIM

5. The Promotion will be conducted at ECQ Outlet (“Participating Centre”).
6. To be eligible, individuals must during the Promotion Period: (a) Visit the activation space within ECQ Outlet; (b) Complete the official sign-up form and successfully subscribe to the ECQ Outlet database with a valid email address. (c) Follow any instructions provided by promotional staff.
7. Each valid entry will receive one (1) ECQ Outlet branded tote bag.

GIFTS

8. Subject to availability and any limits set out in these Terms and Conditions, each valid entry will receive one (1) ECQ Outlet branded tote bag.
9. Gifts are limited to **one (1) per person** and are available while stocks last.
10. A total of 2,400 gifts are available for this Promotion.
11. The total value of gifts available is \$16,440
12. Gifts are not transferable, exchangeable or redeemable for cash.

MAJOR PRIZE DRAW

13. All eligible entrants will be automatically entered into the major prize draw.
14. The draw will take place on Monday 30 March 2026, 10:00 am AEDT at 159 Rooty Hill Rd Southeastern Creek
15. Winners will be notified via phone and email within 2 days of the draw.
16. The prize(s) to be awarded will be determined by the Promoter and may include one or more prizes. Full prize details, including number of winners and prize values, will be confirmed prior to the draw and published on the Eastern Creek Quarter website.
17. The total prize pool value is \$5,000.

18. Prizes are not transferable, exchangeable or redeemable for cash and must be accepted as awarded.
19. If a prize is unavailable, the Promoter reserves the right to substitute the prize with one of equal or greater value, subject to any written directions from a regulatory authority.

GENERAL

13. Each individual is only permitted to make one (1) gift claim per day under this Promotion. Incomplete, indecipherable, or illegible claims will be deemed invalid. Any gifts that remain left over at the conclusion of the Promotion Period will remain the property of the Promoter.

14. The Promoter reserves the right, at any time, to verify the validity of claims (including contacting Participating Retailers) and claimants (including a claimant's identity, age, and place of residence) and to disqualify any claimant who submits a claim that is not in accordance with these Terms and Conditions or who tampers with the claim process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

15. If there is a dispute as to the identity of a claimant, the Promoter reserves the right, in its sole discretion, to determine the identity of the claimant.

16. If the gift is unavailable due to reasons beyond the control of the Promoter, the Promoter in its discretion, reserves the right to substitute the gift with a gift of the equal value and/or specification, subject to any written directions from a regulatory authority.

17. Total value of gifts to be provided under this Promotion is up to \$16,440. Gifts, or any unused portion of a gift, are not transferable or exchangeable and cannot be taken as cash, unless otherwise specified.

18. If this Promotion is interfered with in any way or is not capable of being conducted as reasonably anticipated due to any reason beyond the reasonable control of the Promoter, including but not limited to technical difficulties, unauthorised intervention or fraud, the Promoter reserves the right, in its sole discretion, to the fullest extent permitted by law: (a) to disqualify any claimant; or (b) subject to any written directions from a regulatory authority to modify, suspend, terminate or cancel the Promotion, as appropriate.

19. The Promoter's decision is final, and no correspondence will be entered.

Nothing in these Terms and Conditions limit, exclude or modify or purports to limit, exclude or modify the statutory implied guarantees/warranties as provided under the Trade Practices Act, ASIC Act, or the Competition and Consumer Act including the guarantees under the Australian Consumer Law or similar laws in the State and Territories of Australia ("Non Excludable Guarantees"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including their respective officers, employees, and agents) exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the Promotion.

Except for any liability that cannot by law be excluded, including the Non Excludable Guarantees, the Promoter (including their respective officers, employees and agents) are not responsible for and exclude all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c) any claim or correspondence that is late, lost, altered, damaged or misdirected (whether received by the Promoter or not) due to any reason beyond the reasonable control of the Promoter; (d) any variation in the gift value to that stated in these Terms and Conditions; (e) any tax liability incurred by a claimant; or (f) use of a gift.

PRIVACY

22. In order to conduct this Promotion, the Promoter needs to collect personal information about each claimant and may for this purpose, disclose such information to third parties, including but not limited

to agents, contractors, service providers, gift suppliers and regulatory authorities. Participation in the Promotion is conditional on providing this information.
