TERMS AND CONDITIONS FOR EASTERN CREEK QUARTER

"BACK TO SCHOOL SPEND AND GET - BONUS \$10 Woolworths Voucher"

PROMOTION

1. Information on how to claim and gifts form part of these Terms and Conditions. Participation in this "Back to School Spend & Get – BONUS \$10 Woolworths Voucher" Promotion ("Promotion") is deemed acceptance of these Terms and Conditions.

ELIGIBILTY

2. Subject to condition 3, this Promotion is only open to Australian residents. 3. PROMOTION PERIOD

HOW TO CLAIM

5. The Promotion will be conducted at Eastern Creek Quarter ("Participating Centre")

6. GENERAL

14. The Promoter reserves the right, at any time, to verify the validity of claims (including contacting Participating Retailers) and claimants (including a claimant's identity, age, and place of residence) and to disqualify any claimant who submits a claim that is not in accordance with these Terms and Conditions or who tampers with the claim process. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

15. If there is a dispute as to the identity of a claimant, the Promoter reserves the right, in its sole discretion, to determine the identity of the claimant.

PRIVACY
